**TRAFFIC (AMENDMENT) REGULATIONS, 2026
(SL 34 of 2026)**

In exercise of the powers conferred by sections 22, 44, 56, 66, 128 and 142 of the Traffic Act (2026 Revision), the Cabinet makes the following Regulations —

Citation and commencement

1. (1) These Regulations may be cited as the Traffic (Amendment) Regulations, 2026.
- (2) These Regulations come into force on 1st September, 2026.

Amendment of regulation 1A of the Traffic Regulations (2026 Revision) - definitions

2. The *Traffic Regulations (2026 Revision)* are amended in regulation 1A by inserting, in the correct alphabetical sequence, the following definitions —
 - “**civil partner**” has the meaning assigned by section 2 of the *Civil Partnership Act, 2020*; and
 - “**spouse**” means the male or female party to a marriage.”

Amendment of regulation 27 - fees for inspection, registration, licensing

3. The *Traffic Regulations (2026 Revision)* are amended in regulation 27 as follows —
 - (a) by inserting after paragraph (1), the following paragraph (1A) —
 - “(1A) Where a different fee is prescribed for a Caymanian and a non-Caymanian under paragraphs (3) to (5), the fee payable by the



spouse or civil partner of a Caymanian, who is a non-Caymanian, shall be the fee prescribed for a Caymanian.”;

- (b) in paragraph (3), under the heading “**Item**” —
- (i) by deleting the following items and their related particulars —
- (A) Copy of register entry (per vehicle);
 - (B) Copy of driver’s licence entry (each licence);
 - (C) Plates (per set);
 - (D) Personalised plates (motor cars and trucks not exceeding 10,000 lbs);
 - (E) Personalised plates (motorcycles, mopeds and scooters);
 - (F) Quincentennial plates;
 - (G) Exhibition plates (motor cars and trucks);
 - (H) Exhibition plates (motorcycles, mopeds and scooters);
 - (I) Trade plates, one pair (per quarter);
 - (J) Trade plates, one pair (per annum);
 - (K) Replacement of personalised and quincentennial plates;
 - (L) Replacement of exhibition plates (motor cars and trucks);
 - (M) Replacement of exhibition plates (motorcycles, mopeds and scooters); and
 - (N) Processing fee (termination, and suspension of vehicle); and
- (ii) by substituting the following items and their particulars —

(c) in paragraph (4), under the heading “**Item/Transaction**” —

(i) under the subheading “**Vehicle inspection**”, by deleting “Exhibition vehicles” and the related particulars and substituting the following itemised transaction and its particulars —
